Rulings for the Convention of 1910

- 1. All delegates must bring their credentials properly signed to the convention.
- 2. (a) All active members having a certificate of membership must fill out membership cards.
- (b) The word "certificate" in the question, "Have you a certificate?" means certificate of music.
- 3. Every active member of each chapter must purchase a year book.
- Chapters taking in honorary members must notify all other chapters at once.
- 5. All chapters must vote on names of schools in which to have new chapters within thirty (30) days after notice is received or their vote will be counted affirmative.
- 6. A list of all honorary members shall be printed in the year book.
- 7. The names and addresses of all members of the honorary advisory board shall be printed in the year book.
- 8. Home addresses of all members shall be printed in the year book.
- 9. Names of girls expelled from any chapter shall be printed in the year book.
- Opening and closing ceremonies shall be memorized by both chapter and supreme officers.
- 11. Supreme Treasury shall pay the expenses of one supreme officer in installing a new chapter.
- 12. Two invitations to convention shall be sent to the members of the honorary advisory board, one from the Supreme Secretary, and one from the entertaining chapter.
- 13. All chapters must inform the Supreme Historian about their pictures for the year book at the convention.
